State of the art facilities, for health and phytosanitary inspections, allow the entry of products into the European market following all requirements and specifications, as well as its load / unload, warehousing or handling into the port.

PCF

Occupies an area of 3,800 sqm. where administrative and physical control of the cargo are brought together.

Sixteen inspection docks and 5,900 sqm. for trucks waiting area are also available.

Both breakbulk and reefer container cargo are possible to be handled at the PCF Bilbao.

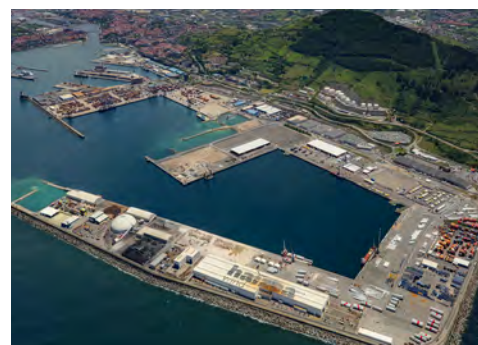
